Dear CPSC,

I have received what appears to be a computer-generated response from you.

That is unacceptable.

<u>1.</u> The last time I was contacted by an investigator he said that your lab would examine the section of hose that I sent you and he would get back to me with the results. No one got back to me with the results.

He was the second investigator on the case; he said that the first investigator (Richard Loera: RLoera@cpsc.gov) had retired.

Did your lab examine the section of hose?

If it did, what were the results?

2. The generator was manufactured in China.

It was distributed in the U.S. by MultiPower Inc.

MultiPower Inc. has long since disappeared. That would explain why they have not responded to you.

That leaves Home Depot (the seller) as the responsible party.

You need to issue a recall and require that Home Depot do one of the following:

- **a.** Send the customers a new hose, one that is rated for propane;
- **b.** Offer customers a money adjustment if they promise not to run the generator on propane; or
- **c.** Buy back the generator.

Note that the propane hose (from the pressure regulator to the carburetor) was secured with common screw/band clamps like the ones used with gasoline hoses. I asked Investigator Loera if these clamps are approved for use with propane hoses. He said he didn't know but would check. He didn't get back to me.



I suspect that these clamps are not approved for use with propane.

Would you let a furnace manufacturer use these clamps (and gasoline rated hose) in a gas furnace?

If these clamps are not approved for use as a propane fitting then the generator cannot be retrofitted for use with propane since it does not have (and cannot be modified to have) approved propane fittings.

You have dropped the ball and put the buyers of the generator at risk.

If you continue to do nothing I will write about it for my Web site (www.jmargolin.com). Then I will contact the House Committee on Energy and Commerce (Subcommittee on Commerce, Manufacturing and Trade) which oversees your agency.
