19 20	A. This action should be dismissed because individual agency officials are not proper defendants in actions under the Freedom of Information Act ("FOIA").					
21	Plaintiff Jed Margolin has sued Charles F. Bolden, Administrator of the National					
22	Aeronautics and Space Administration ("NASA"), for failure to provide certain documents					
23 24	requested under FOIA. But individual agency employees are not proper party defendants in					
25	FOIA actions. Johnson v. Commissioner of Internal Revenue, 2002 WL 31934162 (W.D. Wash.					
26	2002); see also 5 U.S.C. § 552(a)(4)(B) ("[T]he district court of the United States * * * has

any agency records improperly withheld from the complainant[.]") (emphasis added); Hardy v. Daniels, 2006 WL 176531 (D. Or. 2006) ("[T]he general consensus is that only a federal agency, and not federal officials, can be sued under FOIA.") (emphasis in original). Because plaintiff's complaint names only the NASA Administrator as a defendant, dismissal is warranted. **II. CONCLUSION** For the foregoing reasons, this action should be dismissed.
