Sir:

This is an Appeal under the Freedom of Information Act (5 U.S.C. § 552 *et seq.*) to the USAF responses received in response to the above FOIA requests, all filed August 13, 2010 by Jed Margolin ("Margolin").

Because USAF requires that a separate FOIA request be made to each location the requests were all identical.

This Appeal is for all four FOIA requests in order to avoid unnecessary duplication and expense.

Although USAF's responses were sent at different times, this appeal is timely.

## **Introduction**

On August 13, 2010 Margolin filed a FOIA request with four USAF locations for documents relating to the use of Synthetic Vision in the C-130 and its variants. The locations were:

ACC - Dyess Air Force Base, Texas;  
AMC - Little Rock AFB, Ark.;  
USAFE - Ramstein Air Base, Germany;  
PACAF - Yokota AB, Japan.

Because USAF requires that a separate FOIA request be made to each location the requests were all identical. See Exhibit 1 Appendix at AFA4 for the FOIA request.

Margolin asked for a full waiver of all fees based on the Journalist Exemption. See Exhibit 2 Appendix at AFA7.

See Exhibit 3 Appendix at AFA12 for the FOIA receipts.

## **Results**

USAF's responses to Margolin's FOIA request have been mixed but poor, sometimes very poor.

### **1.** AMC - Little Rock AFB, Ark. ("Little Rock") - FOIA #2010-06809-F

On August 18 Little Rock started by saying Margolin's request was too broad. (See Exhibit 4 Appendix at AFA17). On August 23 Margolin explained that it was not. (See Exhibit 5 Appendix at AFA19). On August 30 Little Rock responded by saying no records were found but waived all fees. (See Exhibit 6 Appendix at AFA23.)

Margolin appeals this decision by USAF to withhold documents based on hard evidence that synthetic vision is, indeed, used in the C-130.

### **A.** Email from Robert DuRall (Cobham Avionics) to Robert Adams (Optima Technology Group).

This email was provided to Margolin by Optima Technology Group. (See Exhibit 7 Appendix at AFA25.)

Mr. DuRall states:

The Cobham Avionics/Chelton Flight Systems Synthetic Vision EFIS has received FAA STC and is installed on over 650 different Part 23 aircraft, Bell 206/407/204/205/210, Eurocopter EC-120/AS350/AS355, and the Cessna C500/C550. We hold a smaller number of EASA ESTCs and a TCCA STC. Enstrom Helicopters and MD Helicopters own STCs

with our EFIS on some of their model airframes. Additionally, our EFIS is installed on C-130 aircraft and other large military/para-military aircraft and rotorcraft. There are too many aircraft to list in a single e-mail response.

{Emphasis added}

**B.** Product brochure from Esterline Technologies Corporation/CMC Electronics for their TacView® Portable Mission Display. [http://www.esterline.com/Portals/17/Documents/en-us/MilAv\\_TacView\\_brochure.pdf](http://www.esterline.com/Portals/17/Documents/en-us/MilAv_TacView_brochure.pdf).

Their product brochure shows their synthetic vision product being used in a C-130. The brochure is reproduced as Exhibit 8 Appendix at AFA27.



Little Rock's statement that they have no records relating to the use of synthetic vision is not credible unless USAF want to assert that their record keeping is so poor they have no idea what equipment is actually used in their aircraft.

## 2. ACC - Dyess Air Force Base, Texas ("Dyess")

In a letter dated August 18, 2010 Dyess stated that no records responsive to Margolin's FOIA request were found. Dyess also waived all fees. See Exhibit 9 Appendix at AFA32.

Margolin appeals USAF's decision based on the same evidence produced above in response to Little Rock.

Margolin wishes to note that the letter from Dyess does not contain a reference to the FOIA case number. Perhaps Dyess used the same care in searching for responsive documents that they used in drafting their letter.

### **3.** USAFE - Ramstein Air Base, Germany ("Ramstein")

Margolin received no response from Ramstein. None at all.

### **4.** PACAF - Yokota AB, Japan - 2010-06811-F

This is where USAF has truly embarrassed themselves.

The Yokota response came on August 25 from Roger V. Hansel ("Hansel") at Hickam AFB, who refused Margolin's request for a fee waiver. See Exhibit 10 Appendix at AFA34.

Margolin has filed several FOIA requests with USAF in the past several months for the article/blog he has been writing about his experiences with how USAF responds to FOIA requests.

Because of his experiences, the article/blog is called:

#### **How the United States Air Force Plays the Shell Game with the Freedom of Information Act and How They Treat Independent Inventors**

As is apparent by the title, Margolin's experiences with USAF have not been positive.

As time has gone by, USAF has adopted the strategy of denying Margolin's request for a fee waiver even though his article/blog is in the Public Interest.

The article/blog is at [http://www.jmargolin.com/usaf/usaf\\_web.htm](http://www.jmargolin.com/usaf/usaf_web.htm) and is updated as events occur, more-or-less.

The current version is reproduced in Exhibit 11 Appendix at AFA36.

Because of Margolin's previous experiences with USAF denying his request for a fee waiver, Margolin cut to the chase in an email responding to Hansel's denial. Nevertheless Margolin offered to compromise. Margolin's email is reproduced in Exhibit 12 Appendix at AFA59. The files attached to Margolin's email are appended. (One of the files has been reformatted to make it

more readable. The file *f2\_07a\_langley.txt* is about 276 pages. It has been truncated here to the first ten pages and last ten pages.)

Hansel was not interested in being reasonable. All he wanted to do was play bureaucratic word games. See Exhibit 13 Appendix at AFA92.

He also ignored Margolin's request that he confirm the address at which USAF accepts Legal Service. This will be a running theme through the remainder of the Hansel emails.

The remaining email exchanges have been placed together in Exhibit 14 Appendix at AFA95.

Margolin appeals this decision by USAF to deny him a fee waiver.

The Freedom of Information Act provides:

Documents shall be furnished without any charge or at a charge reduced below the fees established under clause (ii) [5 U.S.C. § 552(a)(4)(A)(ii)] if disclosure of the information is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in the commercial interest of the requester.

If USAF does not like the article/blog that Margolin is writing, the fault is solely due to USAF's actions. USAF is required to comply with the Freedom of Information Act whether or not USAF likes Margolin's article/blog.

Margolin also wants to remind USAF of the **Presidential Memorandum** of January 21, 2009 **Freedom of Information Act Memorandum for the Heads of Executive Departments and Agencies** where the President (USAF's Commander-in-Chief) ordered the Heads of Executive Departments and Agencies, which includes USAF and the Secretary of the Air Force:

The Freedom of Information Act should be administered with a clear presumption: In the face of doubt, openness prevails. The Government should not keep information confidential merely because public officials might be embarrassed by disclosure, because errors and failures might be revealed, or because of speculative or abstract fears. Nondisclosure should never be based on an effort to protect the personal interests of Government officials at the expense of those they are supposed to serve. In responding to requests under the FOIA, executive branch agencies (agencies) should act promptly and in a spirit of cooperation, recognizing that such agencies are servants of the public.

This Presidential Memorandum is reproduced as Exhibit 15 Appendix at AFA108. It appeared in the Federal Register Vol. 74, No. 15, Monday, January 26, 2009, and is available online at [http://www.justice.gov/oip/foia\\_guide09/presidential-foia.pdf](http://www.justice.gov/oip/foia_guide09/presidential-foia.pdf)

### **Conclusion**

1. Little Rock and Dyess assert there are no responsive documents to Margolin's FOIA request for documents relating to the use of synthetic vision on the C-130 (and its variants). The evidence says that synthetic vision is used on the C-130. Margolin requests that Little Rock and Dyess perform a proper search as required by the Freedom of Information Act.
2. Ramstein has not responded at all.
3. Roger V. Hansel ("Hansel") at Hickam has refused Margolin's request for a fee waiver, acted in bad faith toward Margolin, and embarrassed himself and USAF.

Margolin requests that all fees be waived and that USAF perform its duty required by the Freedom of Information Act.

Margolin also requests that Hansel be transferred to a location more suited to his abilities and temperament, like Thule Air Base.

## **Freedom of Information Act Fee Waiver Request - Journalist Exemption**

I claim the journalist exemption.

I have Web sites where I write about issues of general interest as well as issues of more specific interest.

Here are some examples.

**1.** I wrote about my experiences at O'Connor Hospital in San Jose, California because, as is fairly standard hospital practice, they proposed to charge me more than twice the amount they charge insurance companies for the same services. I also investigated their activities and discovered they were violating the terms of their 501(c)(3) tax-exempt status.

As a result of my article, the California Statewide Communities Development Authority (CSCDA) stopped issuing them tax-free bonds until they re-qualified for them.

Not long afterwards, the Daughters of Charity (owners of O'Connor Hospital) came out with a new policy where they promised to charge people without medical insurance the rates equal to what Managed Care would pay.

**2.** My mailing address has a zip code in Washoe County even though I live in Storey County. I wanted to know if the Census Bureau was going to count me for the county where I actually live because if they counted me for the wrong county then my county would lose money and representation.

I investigated and found the answer. It wasn't easy because many people at the Census Bureau didn't know the answer.

There are other people in a similar situation. Now they can know the answer, too.

**3.** When a Developer came into Storey County (population ~4,600) and wanted to build a Master Planned Community for 50,000 people many of us were concerned because, among other things, the Developer refused to say where he was planning to get the water for his community. (Water is always an issue in the West.)

When I learned that the Storey County Web site was not set up to archive and index the large number of documents involved in the issue I set up a Web site on my own: <http://www.cordevistahoa.org>

I also did some independent investigation.

The Storey County Planning Commission denied the Developer's Application for a change to the County's Master Plan and for a change in zoning, and the Storey County Commissioners accepted the recommendation of the Planning Commission in denying the Developer's applications.

I was publicly thanked by the Planning Commission for setting up the Web site.

This is more than a purely local issue.

The Developer sued the County. The case was heard by Retired Nevada Supreme Court Chief Justice Miriam Shearing. In her decision in favor of the County she said:

This court must give deference to the legislative determination of the Storey County Commission that it did not wish to amend its Master Plan. Although the Nevada Supreme Court has not dealt directly with the standard of review of a county decision not to amend a master plan, it is clear that the court must be highly deferential to the enacting body. As the Nevada Supreme Court said in *Coronet Homes, Inc. v. McKenzie*, 84 Nev. 250, 255-56, 439 P.2d 219, 223 (1968), in the context of a land use request:

The days are fast disappearing when the judiciary can look at a zoning ordinance and, with nearly as much confidence as a professional zoning expert, decide upon the merits of a zoning plan and its contribution to the health, safety, morals or general welfare of the community. Courts are becoming increasingly aware that they are neither super boards of adjustment nor planning commissions of last resort.

Nevada law, thus, is consistent with the law of Minnesota as articulated in *Concept Properties, LLP v. City of Minnetrista*, 694 N.W. 2d 804, 814 (Minn. App. 2005). A municipal body acts in a legislative capacity when it adopts or amends a comprehensive land-use plan. *Id.* Municipal bodies have broad discretion in making zoning and land-use decisions. *Id.* Courts will reverse zoning decisions only where there are no grounds for reasonable debate and where the action of the municipal body is arbitrary, capricious, discriminatory, or illegal. *Id.* The evidence presented by Virginia Highlands was not sufficient to support the view that any of these defects apply to the Storey County refusal to amend its Master Plan.

Thus, she clearly articulated the apparently novel ideas that:

1. Courts are not a Super-Planning Commission.
2. Counties have the right to determine their own destiny.

It should be noted that the Developer chose a name for his company (Virginia Highlands LLC) that is remarkably similar to my community's name (Virginia City Highlands), which did not endear him to us.

**4.** A huge Japanese conglomerate using a Reno company as its local face proposed to put up 70 huge wind turbines on land managed by the Bureau of Land Management (BLM). Some of the wind turbines would have been less than a mile from historic Virginia City. Some of them would have been less than a mile from my community (which they left off their map.)

I set up a Web site (<http://www.storeycountywindfarms.org>), obtained documents from BLM including the Application and public comments (most of which were opposed to the project), and the project is now moribund.

**5.** I blogged my experiences with the U.S. Patent and Trademark Office, and then the Court of Appeals For the Federal Circuit, so people could see how their Government works.

**6.** I am currently blogging my experiences with the National Aeronautics and Space Administration (NASA). I filed suit against NASA in U.S. District Court for the District of Nevada for NASA's refusal to comply with the Freedom of Information Act.

Again, this is to show people how their Government works.

**7.** In *Federal Cure v. Harley G. Lappin*, heard in the District Of Columbia District Court (Case Number 1:2007cv00843), the Court ruled that a fee waiver cannot be denied simply because the Requestor distributes material solely through a website.

**8.** In the interests of full disclosure, I am the named inventor on U.S. Patent 5,566,073 ('073) **Pilot aid using a synthetic environment** and U.S. Patent 5,904,724 ('724) **Method and apparatus for remotely piloting an aircraft**. The '073 patent teaches the use of what is now called *synthetic vision* in manned aircraft. The '724 patent teaches the use of synthetic vision for controlling unmanned aerial vehicles (UAVs).

In June 2003 I filed an administrative claim for patent infringement with the NASA Headquarters Office of General Counsel for NASA's use of synthetic vision in their X-38 project. (It was NASA's idea for me to file the claim.) NASA's criminal misconduct in handling my claim was revealed as a result of the 4,000 or so pages of documents NASA has produced as a result of my FOIA lawsuit against them.

I no longer own the Patents. When I assigned the Patents to Optima Technology Group the claim went with them.

Although I have a financial interest in the Patents in the form of royalties I do not control them. The odds that I will make money from the Patents as a result of my FOIA requests are small.

My FOIA requests are not about money.

They are about fairness and honesty and how Government works.

For example, an article was published in the December 2008 issue AUVSI's *Unmanned Systems Magazine* titled **Synthetic Vision Technology for Unmanned Systems: Looking Back and Looking Forward**. The authors are Jeff Fox, Michael Abernathy, Mark Draper and Gloria Calhoun.

Jeff Fox is with NASA, Michael Abernathy is with Rapid Imaging Software, Mark Draper and Gloria Calhoun are with AFRL. The article presents a spurious history of synthetic vision. It asserts (wrongly) that NASA invented it. The article is malicious.

I responded with the article **Synthetic Vision – The Real Story**.

Although the editor of AUVSI Magazine had promised me the opportunity to respond in the magazine, he later refused to even mention the controversy about the Abernathy article.

I say the “Abernathy article” because Jeff Fox’s inclusion as an author was a late addition; his name was not included on the preview copy Abernathy gave NASA. There is no evidence that Fox contributed in a material way to the article. His name was added to give the article credibility.

Mark Draper and Gloria Calhoun are both USAF employees at AFRL and are listed as such in the article. By allowing their affiliation to be used, USAF gave its approval to the article.

The information I am requesting in my FOIA request is likely to significantly contribute to public understanding of the operations of USAF because the American People deserve to know if USAF is run by a bunch of crooks.

9. I am currently blogging my experiences with my Freedom of Information Act Requests with USAF so people can see how USAF works.

You wrote:

**>We are unable to process your request, because it is too broad.**

My FOIA Request is very specific and provides a number of specific keywords and search terms. I asked for all documents relating to the use of Synthetic Vision in operating the C-130 (all variants) operated by USAF.

I defined what synthetic vision is:

Synthetic Vision is defined by the FAA in FAA Title 14 Part 1 as follows:

Synthetic vision means a computer-generated image of the external scene topography from the perspective of the flight deck that is derived from aircraft attitude, high-precision navigation solution, and database of terrain, obstacles and relevant cultural features.

You wrote:

**> Please clarify and provide any additional information as to what type of records you are seeking and what office maintains your requested information to clarify its affiliation with the United States Air Force.**

I directed my FOIA request to: Dyess Air Force Base, Texas; Little Rock AFB, Ark.; Ramstein Air Base, Germany; and Yokota AB, Japan because those are the four active duty locations listed as flying the C-130. I assume you are responding for Dyess.

Without specific information, we are unable to direct your request to the appropriate office or agency. When responding, please reference our case number in your letter.**

I'm sorry, but your position is totally unsupportable by both the letter and spirit of the Freedom of Information Act, the orders of the President of the United States in his memo of January 21, 2009 (Memorandum for the Heads of Executive Departments and Agencies; Subject: Freedom of Information Act), and by case law.

In *Vaughn v. Rosen* 484 F2d 820, 157 U.S.App.D.C. 340 the Court explained:

The Freedom of Information Act was conceived in an effort to permit access by the citizenry to most forms of government records. In essence, the Act provides that all documents are available to the public unless specifically exempted by the Act itself.<sup>10</sup> This court has repeatedly stated that these exemptions from disclosure must be construed narrowly, in such a way as to provide the maximum access consonant with the overall purpose of the Act.<sup>11</sup> By like token and specific provision of the Act, when the Government declines to disclose a document the burden is upon the agency to prove de novo in trial court that the information sought fits under one of the exemptions to the FOIA.<sup>12</sup> Thus the statute and the judicial interpretations recognize and place great emphasis upon the importance of disclosure.

In light of this overwhelming emphasis upon disclosure, it is anomalous but obviously inevitable that the party with the greatest interest in obtaining disclosure is at a loss to argue with desirable legal precision for the revelation of the concealed information. Obviously the party seeking disclosure cannot know the precise contents of the documents sought; secret information is, by definition, unknown to the party seeking disclosure. In many, if not most, disputes under the FOIA, resolution centers around the factual nature, the statutory category, of the information sought.

{Emphasis added}

The Court trumps USAF's FOIA regulations and/or your interpretation of USAF regulations.

I do not have to identify specific records. That's your job.

Since you are obviously stonewalling my FOIA Request, please confirm that I have exhausted all the administrative remedies that USAF has to offer and that the address at which USAF accepts legal service is:





After my experiences with NASA I thought the United States Air Force would at least deal with me honestly and honorably. They didn't.

It started when the launch of the X-37B made the news in April 2010.

There was a fair amount of press coverage about the X-37B launched on April 24, 2010. It was even mentioned on various network radio newscasts.

The X-37 was a NASA project that was started in 1998 and canceled in 2003. Only it wasn't canceled. It was taken Black by transferring it, first to DARPA, and then to the United States Air Force.

It was a big secret until shortly before the launch.

This is how it went.



Since I did not think the X-37B was developed by the Air National Guard, that left only 130 possible locations for me to send my FOIA request to.

You cannot make your request and click which locations you want it sent to. You can only send it to one location at a time. Then you start over and send it to another location.

Here is the list of locations. I have attempted to group them according to the Centers they are associated with. In some cases I have looked up the web sites for the locations. [Click here.](#)

There are some Centers that don't seem to have a Location, such as AFOTEC. It's a mystery.

I filed my FOIA requests on Monday morning, April 26, 2010.

Air Vehicles Directorate -- With headquarters at Wright-Patterson AFB, Ohio, the Air Vehicles Directorate leads the effort to develop and transition superior technology solutions that enable dominant military aerospace vehicles. The emphasis and vision are on technology investments that support cost-effective, survivable aerospace vehicles capable of accurate and quick delivery of a variety of future weapons or cargo anywhere in the world. To achieve this, core technology areas focus on aeronautical sciences, control sciences, structures and integration. The directorate targets advanced concepts to direct the development of vehicle technologies that provide future capabilities in the areas of sustainment, unmanned air vehicles, space access and future strike.

**Unfortunately, AFRL is not on the Locations list so you cannot make a request to AFRL.**

This is what we have learned so far. If you are a Federal Agency (such as USAF) and you are subject to the Freedom of Information Act, and you want to keep some of your activities out of the reach of the Freedom of Information Act you:

1. Set up a system that requires Requestors send a separate request to each location.
2. Leave the department to be protected off the list.

That is what USAF has done with AFRL.

Later that day on Monday I received a phone call from someone who identified himself as Technical Sergeant Kennerly.

He said he had noticed that I had filed several FOIA requests that appeared to be identical, and were they in fact identical?

I said, "yes", because the USAF FOIA Web site requires that a separate request be made to each location.

Then I explained to him the basics of Synthetic Vision, and then Technical Sergeant Kennerly said he had some other things he had to do.

On Tuesday Morning, April 27, 2010 I received an email from Darrin Booher ("Booher"), a FOIA Analyst at Wright-Patterson. In it he denied my request for a fee waiver because:

"There is no contribution to an understanding of the subject by the general public, but rather a small segment of interested persons. Requestor doesn't appear to have the capability to, or intention to, disseminate this information to the general public. Furthermore, there is no significant contribution to the public if it were widely released. Therefore, the request for a waiver of fees is denied."

Booher gave me until April 30 to indicate how much money I was willing to pay.

Gentle Reader, since you are now reading this, what do you think of my "capability to, or intention to, disseminate this information to the general public" especially if you are reading it on my Web site?

I called Technical Sergeant Kennerly and told him of the Booher email.

Technical Sergeant Kennerly said to ignore it, that my FOIA request was going to be handled by the Pentagon. He also asked me to forward him a copy of the Booher email, which I did. [Click here for my email to Technical Sergeant Kennerly.](#)

Nonetheless, I responded to Booher. [Click here.](#)

Booher responded by closing my FOIA request without responding to my email. [Click here.](#)

I did not think it was a big deal, just the actions of a nasty civilian government bureaucrat. After all, Technical Sergeant Kennerly had told me that my FOIA request was going to be handled by the Pentagon.

In the Air Force, the rank of Technical Sergeant is a big deal.

Technical Sergeant, or Tech Sergeant, is the sixth enlisted rank (E-6) in the U.S. Air Force, just above Staff Sergeant and below Master Sergeant. A technical sergeant is a non-commissioned officer and abbreviated as TSgt. Official terms of address are "Technical Sergeant" or "Sergeant", although many use "Tech Sergeant".

Within the enlisted Air Force, promotion to TSgt has historically been the second most difficult rank to achieve (only the rank of Senior Master Sergeant, capped by Federal law, has lower promotion rates) and is the most difficult promotion most career Air Force members achieve. To be considered for a promotion to Technical Sergeant, a Staff Sergeant must have 6 years' time in service and 24 months time in grade, however, 10–12 years time in service is normally when this grade is reached. Technical Sergeants provide technical mentorship to junior enlisted members in preparation for entry into the senior noncommissioned tier and promotion to the rank of Master Sergeant.

With Technical Sergeant Kennerly handling the matter, what could possibly go wrong?

The SAF FOIA office at the Pentagon will respond to your FOIA request (reference: Case No. 2010-04186-F). Therefore, we have closed Case No. 2010-04191-F here at Patrick AFB. All future inquiries/correspondence concerning Case No. 2010-04186-F should come from that office.

Upon transfer of your case #2010-04190-F, we were informed that this is a duplicate of case #2010-04842-F which is already being handled by HAF/IMIO. For this reason we will close case #2010-04190-F at the Rome FOIA office.

The Office of The General Counsel, Intellectual Property Office conducted a proper search for records relating to Items 2 and 5 of your request; however, no information was found. Therefore, a no records determination was made.

Should you decide that an appeal to this decision is necessary, you must write to the Secretary of the Air Force, Thru: HAF/IMIO (FOIA), 1000 Air Force Pentagon, Washington DC 20330-1000 within 60 calendar days from the date of this letter. It does not apply to any of the other ones, so it does not address departments such as AFRL which is the most likely suspect for having documents related to the X-37B project.

The USAF blew me off. Technical Sergeant Kennerly's role in this is not exactly known but is substantial.

This FOIA request was only about the use of synthetic vision in the X-37B. It's not like I asked about the secret stuff, like what is the X-37B for? Is the cargo bay for bringing stuff up? Is it for bringing stuff down? Is it for delivering weapons? All it has to do is drop titanium rods with a tapered front and small controllable vanes at the back for maneuvering. Maybe with an ablative coating. The kinetic energy delivered from orbit would be devastating. Is it for anti-satellite activities? Being about to pull up right next to LEO and MEO satellites makes disabling a satellite easier and less detectable than firing something from the ground. I suggest the USAF put out the cover story that the purpose of the X-37B is to investigate the feasibility of in-orbit refueling of satellites. They could maneuver it wherever they wanted without being accused of having a nefarious purpose. It wouldn't violate any Space Treaties. It would be a benign and peaceful use.

I haven't asked about the use of Synthetic Vision in the F-22 and F-35, or the Common Ground Stations for the Predator and Global Hawk UAVs.

USAF has created a cumbersome method of implementing its duties under the Freedom of Information Act by requiring a request be made separately to each location.

Then it complains when identical requests are made to a number of locations.

Then it plays the Shell Game so it can say it does not have responsive documents.

The purpose of the Freedom of Information Act is to allow citizens to understand how their government works.

By gaming the Freedom of Information Act USAF has shown how Government works.

The 9th Reconnaissance Wing is responsible for delivering timely, relevant, and persistent high altitude intelligence, surveillance and reconnaissance, deploying warrior Airmen, and leveraging technology to increase capability for our joint partners. To accomplish this mission, the wing is equipped with the nation's fleet of U-2 and RQ-4 reconnaissance aircraft and associated support equipment. The wing also maintains a high state of readiness in its combat support and combat service support forces for potential deployment in response to theater contingencies. The 9th Reconnaissance Wing is composed of more than 3,000 personnel in four groups at Beale and multiple overseas operating locations.

2. I would like all documents relating to the use of Synthetic Vision in operating the RQ-4 and other Unmanned Aerial Vehicles, Unmanned Aerial Systems, or Remotely Piloted Vehicles operated by the Air Force.

A. Synthetic Vision is defined by the FAA in FAA Title 14 Part 1 as follows:

Synthetic vision means a computer-generated image of the external scene topography from the perspective of the flight deck that is derived from aircraft attitude, high-precision navigation solution, and database of terrain, obstacles and relevant cultural features.

The Office of the Secretary of Defense's *UAV Reliability Study* (19) issued in 2003 is the most comprehensive review of UAV mishaps to date, the results of which were extracted in large part into DoD's *UAV Roadmap 2002-2007* (21) and served as the basis for the Defense Science Board's analysis of UAV mishaps (20). This study found the aggregate sources of failures in the Air Force's RQ-1 Predator, Navy/Marine's RQ-2 Pioneer, and Army's RQ-5 Hunter were power/propulsion (37%), flight controls (26%), communications (11%), human factors (17%), and miscellaneous (9%). It noted "the proportions of human error-induced mishaps are nearly reversed between UAVs and the aggregate of manned aircraft, i.e., human error is the primary cause of roughly 85% of manned mishaps, but only 17% of unmanned ones." Two theories were offered to explain this observation. First, human influence in UAVs is significantly reduced (e.g., "70% less") and is countered by increased automation. Second, human error rates remain constant between UAVs and manned aircraft and are simply overshadowed by the higher unreliability of other subsystems in UAVs. Although no breakdown of human factors was provided, the study reported "three of the areas (power/propulsion, flight control, and operator training) have historically accounted for 80 percent of UAV reliability failures" and "overall mishap rates for UAVs

could be significantly reduced by focusing reliability improvement efforts in these areas," implying human error-induced mishaps were related to training deficiencies. Additionally, the study suggested UAV operator situational awareness may be degraded by the challenges of "human-machine synergy" when the human is on the ground. **Recommendations included enhance operator training, particularly through simulation in the ground control station (GCS) environment, automate launch and recovery operations, and employ enhanced synthetic vision technology to help UAV operators maintain flight and sensor perspective.** The only additional human factors identified in the Defense Science Board's UAV study (20) were the limited experience level of UAV operators and maintainers, inadequate overall professional development of UAV personnel, and the need to better address takeoff and landing errors.

{Emphasis added.}

Thus, there is good reason to believe that USAF's RQ-4 and other UAVs have and use synthetic vision.

I now have four FOIA cases going.

1. The First FOIA case is mostly about the use of synthetic vision in the X-37B and/or X-40A.

USAF has created a cumbersome method of implementing its duties under the Freedom of Information Act by requiring a request be made separately to each location.

Then it complains when identical requests are made to a number of locations.

Those locations that responded eventually passed it up to HQ.

Then HQ said it has no responsive documents.

Of course they don't. The responsive documents are all at the different locations.

I filed an Appeal.

Then they argued about whether the Appeal I filed was an Appeal.

They had 20 days to respond to the Appeal and failed to do so.

My next step will be to file a Complaint in U.S. District Court for the District of Nevada. When you file a Complaint under the Freedom of Information Act you can file either in U.S. District Court for the District of Columbia or in the District where you live. Nevada is closer. (That's where I live.)

When you sue the United States (the Feds) you must follow the Federal Rules of Civil Procedure Rule 4(i) **SERVING THE UNITED STATES AND ITS AGENCIES, CORPORATIONS, OFFICERS, OR EMPLOYEES.**

This requires that you:

1. Either mail or personally deliver a copy of the Summons and Complaint to the U.S. Attorney for the District in which you bring the action;
2. Mail (by Certified or Registered U.S. Mail) a copy of the Summons and Complaint to the Attorney General of the United States;
3. Mail (by Certified or Registered U.S. Mail) a copy of the Summons and Complaint to the U.S. Agency you are suing.

It's called **SERVING THE UNITED STATES AND ITS AGENCIES, CORPORATIONS, OFFICERS, OR EMPLOYEES.**

The process of Serving is commonly called Legal Service.

The address at which an agency (or anyone) accepts Legal Service is called: *The address at which an agency (or anyone) accepts Legal Service.*

Everyone in the Legal Profession knows what it means.

But not USAF.

When an Agency denies your FOIA Appeal they are required to tell that you have the right to sue them. They are also required to tell you the address at which the Agency accepts Legal Service.

But if you are suing them because they have not responded to your Appeal you aren't given that information.

As far as I can determine the address at which USAF accepts Legal Service is:

Arlington, VA 22209-2403

However, I have not been able to get anyone to confirm it in writing or even an email.

This is one of the running threads through the four FOIA requests.

Dear Mr. Margolin,

This is in response to your 30 July 2010 Freedom of Information Act (FOIA) request, Case Number 2010-0030, FOIAexpress Case # 2010-06428-F, which was for "all documents relating to the use of Synthetic Vision in operating the MQ-1 and MQ-9 Unmanned Aircraft Systems as well as any other Unmanned Aircraft Systems (UAVs) or Unmanned Combat Aerial Vehicles (UCAVs) flown at or by Holloman AFB."

A thorough search was accomplished and it was determined there are no records that refer to a reliability study conducted recommending multiple changes to UAVs including the use of synthetic vision technology. This recommendation has not been implemented on MQ-1 nor MQ-9 aircraft flown by the 49<sup>th</sup> Operations group, nor are they aware of any plan or funding to provide for that capability for any MQ-1 or MQ-9 aircraft in the USAF inventory.

This case has been reviewed and no records related to the request exist at Holloman AFB. If you interpret this "no records" response as an adverse action, you may appeal our decision in writing to the Secretary of the Air Force within 60 days from the date of this letter. If no appeal is received, or if the appeal is postmarked after the conclusion of this 60-day period, the appeal may be considered closed. Mr. Margolin,

By journalist exemption I interpreted your request to mean you requested to be placed in the Educational or Noncommercial Scientific Institution or News Media category as opposed to the commercial category or all others category for fees. This is not an exemption, it is a category which determines assessable fees.

There is no journalist fee waiver exemption. Category determination is one action which determines assessable fees and A request to waive fees assessable to the category you are placed in is a separate action.

The term "representative of the news media" refers to any person actively gathering news for an entity that is organized and operated to publish or broadcast news to the public.

The term "news" means information that is about current events or that would be of current interest to the public.

Examples of news media entities include television or radio stations broadcasting to the public at large, and publishers of periodicals (but only in those instances when they can qualify as disseminators of "news") who make their products available for purchase or subscription by the general public.

These examples are not meant to be all-inclusive. Moreover, as traditional methods of news delivery evolve (e.g., electronic dissemination of newspapers through telecommunications services), such alternative media would be included in this category.

In the case of "freelance" journalists, they may be regarded as working for a news organization if they can demonstrate a solid basis for expecting publication through that organization, even though not actually employed by it. A publication contract would be the clearest proof, but Components may also look to the past publication record of a requester in making this determination.

I have placed you in the other requesters category & provided the appeal procedures.

Regarding fees. The criteria for a fee waiver, which is a separate action, is

Waiver or reduction of the fees is appropriate when it is in the public interest because furnishing the information is likely to contribute significantly to public understanding of the operations or activities of the Department of Defense and is not primarily in the commercial interest of the requester.

Now that you have specifically identified your request as being for a waiver of fees & not just a fee category determination I can address that request as well. Your request does not meet the criteria for a fee waiver. The appeal procedures for a fee waiver are the same as provided for the category determination.

If you choose to appeal either or both the fee waiver denial or the category determination, appeal it in writing to the Secretary of the Air Force. Your appeal should be postmarked no later than 60 calendar days from the date of this e-mail.

Include in your appeal letter the reasons for reconsidering your request for a fee waiver or changing your category determination, and attach a copy of this letter.

Your request remains on hold pending your agreement to being placed in the other requesters category and agreeing to pay fees assessable to requesters in that category. If we have not received a response by 3 September 2010 your request will be closed.

Your protestation that you do not know -and have not been able to find out- the meaning of the term "Legal Service" is hardly credible in view of the legal hair-splitting you are engaging in which has left the Freedom of Information Act in desperate need of Rogaine.  
From The Federal Rules of Civil Procedure Rule 4(b):

(b) ISSUANCE. On or after filing the complaint, the plaintiff may present a summons to the clerk for signature and seal. If the summons is properly completed, the clerk must sign, seal, and issue it to the plaintiff for service on the defendant. A summons — or a copy of a summons that is addressed to multiple defendants — must be issued for each defendant to be served.

From The Federal Rules of Civil Procedure Rule 4(i):

(i) SERVING THE UNITED STATES AND ITS AGENCIES, CORPORATIONS, OFFICERS, OR EMPLOYEES.

(1) United States. To serve the United States, a party must:

(A)(i) deliver a copy of the summons and of the complaint to the United States attorney for the district where the action is brought — or to an assistant United States attorney or clerical employee whom the United States attorney designates in a writing filed with the court clerk — or

(ii) send a copy of each by registered or certified mail to the civil-process clerk at the United States attorney's office;

(B) send a copy of each by registered or certified mail to the Attorney General of the United States at Washington, D.C.; and

(C) if the action challenges an order of a nonparty agency or officer of the United States, send a copy of each by registered or certified mail to the agency or officer.

(2) Agency; Corporation; Officer or Employee Sued in an Official Capacity. To serve a United States agency or corporation, or a United States officer or employee sued only in an official capacity, a party must serve the United States and also send a copy of the summons and of the complaint by registered or certified mail to the agency, corporation, officer, or employee.

(3) Officer or Employee Sued Individually. To serve a United States officer or employee sued in an individual capacity for an act or omission occurring in connection with duties performed on the United States' behalf (whether or not the officer or employee is also sued in an official capacity), a party must serve the United States and also serve the officer or employee under Rule 4(e), (f), or (g).

When I file suit against USAF for failing to comply with the Freedom of Information Act (§552 et seq.) I am required to:

1. Either mail or personally deliver a copy of the Summons and Complaint to the U.S. Attorney for the District in which I bring the action;
2. Mail (by Certified or Registered U.S. Mail) a copy of the Summons and Complaint to the Attorney General of the United States;
3. Mail (by Certified or Registered U.S. Mail) a copy of the Summons and Complaint to the U.S. Agency -in this case USAF- that I am suing.

The term "address at which USAF accepts Legal Service" is the address that I am required to send the Summons and Complaint to under Rule(4)(i).

Normally, the address at which an Agency accepts Legal Service is provided when a FOIA Requestor's Appeal is denied. However, in a related USAF FOIA case my Appeal has been ignored. I expect the same thing to happen here. As a result, I do not have an official statement providing the address at which USAF accepts Legal Service. Your unwillingness to provide it is probative.

Mr. Hansel, with your willful actions to frustrate the intent of the Freedom of Information Act and your pretended ignorance of the meaning of the term "Legal Service" I believe you have given me cause to include you personally as a Defendant in this case.

**Title 3—****Memorandum of January 21, 2009****The President****Freedom of Information Act****Memorandum for the Heads of Executive Departments and Agencies**

A democracy requires accountability, and accountability requires transparency. As Justice Louis Brandeis wrote, “sunlight is said to be the best of disinfectants.” In our democracy, the Freedom of Information Act (FOIA), which encourages accountability through transparency, is the most prominent expression of a profound national commitment to ensuring an open Government. At the heart of that commitment is the idea that accountability is in the interest of the Government and the citizenry alike.

The Freedom of Information Act should be administered with a clear presumption: In the face of doubt, openness prevails. The Government should not keep information confidential merely because public officials might be embarrassed by disclosure, because errors and failures might be revealed, or because of speculative or abstract fears. Nondisclosure should never be based on an effort to protect the personal interests of Government officials at the expense of those they are supposed to serve. In responding to requests under the FOIA, executive branch agencies (agencies) should act promptly and in a spirit of cooperation, recognizing that such agencies are servants of the public.


All agencies should adopt a presumption in favor of disclosure, in order to renew their commitment to the principles embodied in FOIA, and to usher in a new era of open Government. The presumption of disclosure should be applied to all decisions involving FOIA.

The presumption of disclosure also means that agencies should take affirmative steps to make information public. They should not wait for specific requests from the public. All agencies should use modern technology to inform citizens about what is known and done by their Government. Disclosure should be timely.

I direct the Attorney General to issue new guidelines governing the FOIA to the heads of executive departments and agencies, reaffirming the commitment to accountability and transparency, and to publish such guidelines in the *Federal Register*. In doing so, the Attorney General should review FOIA reports produced by the agencies under Executive Order 13392 of December 14, 2005. I also direct the Director of the Office of Management and Budget to update guidance to the agencies to increase and improve information dissemination to the public, including through the use of new technologies, and to publish such guidance in the *Federal Register*.

This memorandum does not create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

The Director of the Office of Management and Budget is hereby authorized and directed to publish this memorandum in the *Federal Register*.
